## Year-To-Year Budget Notes

This narrative describes the change from Barnard Elementary School's FY23 submitted budget to their FY24 initial allocation. FY23 submitted budgets include one-time funds (FY23 Mayor's Recovery and Hold Harmless funds), and changes made by principals and school communities from their initial allocation to tailor their resources to their student population. Barnard's initial FY23 allocation and submitted FY23 budget are included on the [dcpbudget.com](https://dcpbudget.com) website.

Barnard Elementary School's initial FY24 formula allocation is \$9,970,294. This is a decrease of \$123,648 compared to the FY23 submitted budget. School budgets are primarily driven by two factors: enrollment and unique student need. In SY22-23, Barnard's projected enrollment was 601. In SY23-24, the school's projected enrollment is 577, a decrease of 24 students. Barnard is receiving 2 less EL teachers due to a decline in the number of English Learners. Barnard is receiving \$2,818 per student eligible for at-risk funding, bringing their total At-Risk Supplement to \$727,027. To support social-emotional and academic needs, additional per-pupil formula funds are allocated to schools serving higher concentrations of students eligible for at-risk funding. Barnard ES is receiving \$7,828 in at-risk concentration funds because over 40% of their student enrollment is eligible for at-risk funding.

Security funds were excluded from school budget allocations since FY22. Security funds will continue to be managed centrally in FY24. Thus, there is no impact to the school's year-over-year comparison. Barnard is also receiving \$115,000 in FY24 ESSER III funding. This funding is not included in their budget total because these funds are one-time and supplemental to the school's annual DCPS formula funds. Schools were able to request ESSER III funds to sustain their evidence-based acceleration programming.

### Levels of Flexibility Key
