Year-To-Year Budget Notes

Bancroft Elementary School's initial formula allocation is \$10,161,796. This is an increase of \$225,726 compared to last year. School budgets are primarily driven by two factors: enrollment and unique student need. In SY2020-21, Bancroft's projected enrollment was 655. In SY2021-22, the school's projected enrollment is 662, an increase of seven students. Due to a decrease in projected English Learner (EL) enrollment, the school is receiving three fewer EL staff allocations. Bancroft requires two additional general education teachers due to limits on average classroom size.

NEW: Bancroft will also receive additional stimulus funding in the approximate amount of \$243,557 to provide supplemental services to accelerate learning recovery and support students' social-emotional development. These funds are not included in the initial formula allocation total.
