## Year-To-Year Budget Notes

This narrative describes the change from Patterson Elementary School's FY23 submitted budget to their FY24 initial allocation. FY23 submitted budgets include one-time funds (FY23 Mayor's Recovery and Hold Harmless funds), and changes made by principals and school communities from their initial allocation to tailor their resources to their student population. Patterson's initial FY23 allocation and submitted FY23 budget are included on the [dcpsbudget.com](http://dcpsbudget.com) website.

Patterson Elementary School's initial FY24 formula allocation is \$6,055,244. This is a decrease of \$318,697 compared to the FY23 submitted budget. This includes \$182,306 in year-over-year stabilization funding and \$392,284 in Mayor's Recovery funding. School budgets are primarily driven by two factors: enrollment and unique student need. In SY22-23, Patterson's projected enrollment was 271. In SY23-24, the school's projected enrollment is 280, an increase of 9 students. Patterson is receiving 2 less special education educators due to a decline in students with IEPs and/or students served in self-contained classrooms. Patterson is receiving \$2,818 per student eligible for at-risk funding, bringing their total At-Risk Supplement to \$707,302. To support social-emotional and academic needs, additional per-pupil formula funds are allocated to schools serving higher concentrations of students eligible for at-risk funding. Patterson ES is receiving \$112,848 in at-risk concentration funds because over 70% of their student enrollment is eligible for at-risk funding.

Security funds were excluded from school budget allocations since FY22. Security funds will continue to be managed centrally in FY24. Thus, there is no impact to the school's year-over-year comparison.

### Levels of Flexibility Key
