


# Fiscal Year 2021 (FY21) DCPS Submitted School Budget: H.D. Cooke ES



## Notes:

H.D. Cooke's initial formula allocation was \$6,859,346. There was no change in the submitted budget total. This is an increase of \$784,451 compared to last year. School budgets are primarily driven by two key factors: enrollment and unique student need. In SY19-20, H.D. Cooke's projected enrollment was 395. For SY20-21, their projected enrollment is 401, an increase of 6 students. At the same time, due to an increase in the number of students receiving special education services with more intensive needs, H.D. Cooke requires 1 additional self-contained special education classroom, resulting in an increased allocation of staff members and overall special education allocation. Additionally, due to an increase in the number of English Language Learners (ELL), H.D. Cooke is receiving an increased ELL allocation.
